- · Inteaz ALLI (also a past chair) will keep us advised on various Membership matters.





EXECUTIVE MEETING SUMMARY By JP AMIEL

Here is a brief description of some of the items reviewed, discussed and approved at our April 21 meeting:

JP AMIEL is completing the Section's 48 year history as originally started by Len Barth. He was confirmed as Section Historian. Ray DYER was confirmed as Section Data chair and explained that the Web page at asquet has advertised our last two events. He also did an analysis of ASQ members who are listed on the asquet registry and finds that our Section is well represented when compared to other Canadian and US Sections. He sees this as an opprotunity to advertise our Section.

Bernard DOIRON reported on the successful presentations on Supplier qualifications and was happy to state that the personnalized invitations extended to new members encouraged four of them to attend this event. Based on his recent readings, JP AMIEL suggested that we hold some of our monthly events on Wednesdays as proposed by a 1991 survey of the membership. He reminded the Executive that they should prepare a brief text for the "Old member/New member" night next month.

Inteaz ALLI and Rob FAIRBAIRN (past and new SMP coordinators) contacted Headquarters to verify/confirm deadlines and required submissions. Three members of the Executive will attend a one-day ASQ Leadership Training Workshop in Toronto at the end of May. This will be a first for the Section and is seen as a great opportunity for its continued success.

Ray DYER noted that Headquarters will no longer provide a membership list. As Data chair, it will be his job to "download" the file as required. Bernard DOIRON will stand-in for Raymond DYER at the next Koality Kid "pep rally" later this month at Allion School. David TOZER reported that the latest Preparation for ASQ certification course is almost finished. Norm DICKIN-SON reported that Headquarters has changed some of the rules regarding recertification and awaits for candidate confirmation before making arrangements for the next exams.

Your Executive meets at the Overhaul shops of the STCUM on May 6 at 6:00PM to start the next Strategic Planning exercice (a first step in the preparation of the Section Management Plan). The next regular Executive planning meeting will be held on May 20, also at the STCUM. We typically meet every third Tuesday of the month, about ten times a year. SUPPLIER QUALIFICATION By JP AMIEL

For those who missed it, the April 21 presentation on Supplier Qualification presented two different approaches. A most interesting topic which we hope to repeat at some later date.

Les Technologies Industrielles SNO - A world-wide supplier of military armament supplies.

Mr David MARTIN spoke on the approach that will be used to ensure product quality levels for a new procuct line. They will be soon launching a product which involves the selectic of subcontractors and suppliers in a new domain for the company. Their objective is to ensure that their suppliers have the necessary tools to ensure product conformity. Their approach is to use the ISO-3951 Inspection by Variables standard as the basis for establishing sampling and product quality verification.

The supplier will identify a sample from his lot and inspect it, submit the results via e-mail to SNC according to a predefined format and then ship it. A technician at SNC will examine the submitted data for conformance, perform an inspection of the identific inspected lot to confirm inspection results and sample check the submitted lot. This will serve as the basis for accepting the lots, track supplier per formance and ensure product conformity.

La Société de transport de la Com munauté urbaine de Montréal (STCUM) - A supplier of urban transport services.

Mr Denis CONSTANTINEAU described the process developped over

the last five years for the selection of suppliers and improving product quality levels on parts and components with technical specifications or drawings. These products have a major impact on the maintenance of the vehicles and equipment of the company and the relaibility of the service offered to the customer.

To ensure a certain level of product quality for these products, the STCUM chooses its suppliers from its list of qualified suppliers. They are encouraged to develop quality systems based on the ISO-9000 standards. Any supplier wanting to be considered for bids goes through a qualification process which includes a preliminary survey describing parts, products and services offered, signing of a quality commitment statement and an audit to verify quality system operation.

However, even though it has a list of qualified suppliers, for orders above \$100,000, the STCUM use public tenders. For that process suppliers must demonstrate their ability to meet all administrative, technical and quality requirements and be the lowest conforming bidder. This qualification process significantly reduced rejections (thus out-of-stocks) at incoming inspection.

(Assign telephone numbers?)


"It's our responsibility to interactively disseminate market-driven opportunities to set us apart from the competition."
